

THIS STANDARD CLAUSE (FOR NEW COMPONENTS) SPECIFIES THE INTEGRATED LOGISTIC SUPPORT PRODUCTS AND SERVICES TO BE PERFORMED BY THE SELLER FOR ENGINEERED COMPONENTS. IT IS PREFERABLE THAT ALL LOGISTIC DATA BE PROVIDED ON WINDOWS COMPATIBLE FILES ON DIGITAL VERSATILE DISKS (DVDS) OR VIA THE CONTRACTOR ELECTRONIC DATA EXCHANGE. IF THIS CAPABILITY IS NOT AVAILABLE, PROVIDE THE DATA IN HARD COPY FORMAT. THE SERVICES REQUIRED ARE DESCRIBED IN THE FOLLOWING PARAGRAPHS:

SUPPLY SUPPORT

THE SELLER SHALL PROVIDE THE FOLLOWING PROVISIONING DATA FROM THE TOP ASSEMBLY DRAWING FOR THE EQUIPMENT/COMPONENTS SPECIFIED IN THIS ORDER:

THE SELLER WILL PROVIDE AN APPROVED DRAWING AND A LIST OF POSSIBLE REPAIR PARTS KEYED TO THE PARTS LISTS OF THE TOP ASSEMBLY DRAWING AND SUB-ASSEMBLY DRAWINGS (REPAIR PARTS INCLUDE COMPONENTS MODULES, SUB-ASSEMBLIES, PIECE PARTS, OR END ITEMS WHICH ARE USED AS REPLACEMENTS FOR FAILED COMPONENTS DUE TO WEAR OR DEGRADATION). THE LIST SHALL INCLUDE THE FOLLOWING DATA FOR EACH INDIVIDUAL ITEM RECOMMENDED AND FOR THE EQUIPMENT/COMPONENTS SPECIFIED:

- ORIGINAL EQUIPMENT MANUFACTURER (OEM)
COMMERCIAL AND GOVERNMENT ENTITY (CAGE) .
- OEM PART NUMBER.
- OEM NAME.
- ITEM NAME.
- PRODUCTION LEAD TIME.
- UNIT OF ISSUE PRICE.
- NATIONAL STOCK NUMBER (IF KNOWN) .
- UNIT WEIGHT.
- QUANTITY REQUIRED PER ASSEMBLY.
- QUANTITY REQUIRED PER END ITEM.
- IDENTIFICATION OF CONSTITUENT MATERIAL.
- MATERIAL NAME AND ASSOCIATED MATERIAL SPECIFICATION

APPLICABLE TO THE LOWEST PART FOR WHICH INFORMATION IS READILY AVAILABLE.

IF THE PRECEDING INFORMATION IS, OR WILL BE, PROVIDED TO THE BUYER TO SATISFY OTHER REQUIREMENTS OF THIS ORDER OR PURCHASE ORDER, THE SELLER NEED NOT RE-SUBMIT THAT DATA SOLELY TO SATISFY THESE REQUIREMENTS.

THE BUYER AND U.S. NAVY MAY USE AND REPLICATE ANY INFORMATION, TECHNICAL DATA, COMPUTER SOFTWARE, AND/OR COMPUTER SOFTWARE DOCUMENTATION PROVIDED UNLESS SPECIFIC PROPRIETARY RIGHTS ARE IDENTIFIED BY THE SELLER.

ALL TECHNICAL DATA PERTAINING TO "NONCOMMERCIAL ITEMS" THAT IS PROVIDED SHALL COMPLY WITH AND BE PROPERLY MARKED IN ACCORDANCE WITH DFARS 252.227-7013, RIGHTS IN TECHNICAL DATA NONCOMMERCIAL ITEMS.

ALL TECHNICAL DATA PERTAINING TO "COMMERCIAL ITEMS" THAT IS PROVIDED SHALL COMPLY WITH AND BE PROPERLY MARKED IN ACCORDANCE WITH DFARS 252.227-7015, TECHNICAL DATA COMMERCIAL ITEMS.

ALL NONCOMMERCIAL COMPUTER SOFTWARE AND NONCOMMERCIAL COMPUTER SOFTWARE DOCUMENTATION THAT IS PROVIDED SHALL COMPLY WITH AND BE MARKED IN ACCORDANCE WITH DFARS 252.227-7014, RIGHTS IN NONCOMMERCIAL COMPUTER SOFTWARE DOCUMENTATION.

ALL SUCH INFORMATION, TECHNICAL DATA, COMPUTER SOFTWARE AND COMPUTER SOFTWARE DOCUMENTATION PROVIDED WITH OTHER THAN UNLIMITED RIGHTS SHALL BE ACCOMPANIED BY A PROPERLY COMPLETED EB FORM NO. 84-02-5667, "NOTICE OF LIMITATION ON GOVERNMENT'S AND OTHER'S RIGHTS."

THE PARTIES AGREE TO ENTER INTO A WRITTEN NON-DISCLOSURE AGREEMENT (NDA) / PROPRIETARY DATA AGREEMENT (PDA) WHEN REQUIRED BY THE AFOREMENTIONED DFARS CLAUSES.

ANY TECHNICAL DATA THAT IS PROPRIETARY, IF PROVIDED, SHALL BE USED ONLY IN SUPPORT OF LOGISTIC SUPPORT PRODUCT DEVELOPMENT.

DELIVER THIS DATA TO THE BUYER WHEN THE INITIAL SET OF ENGINEERING DRAWINGS IS PROVIDED TO SUPPORT THE RELEASE FOR MANUFACTURE.

SUPPORT EQUIPMENT

THE SELLER SHALL IDENTIFY SUPPORT EQUIPMENT WHICH INCLUDES, BUT IS NOT LIMITED TO, SUCH ITEMS AS TOOLS, TEST EQUIPMENT, AND MAINTENANCE AIDS REQUIRED TO INSPECT, TEST, CALIBRATE, SERVICE, REPAIR OR OVERHAUL THE EQUIPMENT AND COMPONENTS SPECIFIED IN THIS ORDER, OR WHICH ARE REQUIRED AS CALIBRATION EQUIPMENT FOR OTHER SUPPORT EQUIPMENT IDENTIFIED IN THIS ORDER. THE SELLER SHALL FURNISH SUPPORTING TECHNICAL DOCUMENTATION AS REQUIRED TO INDICATE THE PHYSICAL CHARACTERISTICS (E.G., DIMENSIONS, MATERIALS) AND FUNCTIONS OF THE SUPPORT EQUIPMENT. THE SELLER SHALL PROVIDE EXISTING CALIBRATION AND OPERATING PROCEDURES.

IF THE SUPPORT EQUIPMENT IS ITSELF A REPAIRABLE ITEM,

PROVISIONING DATA MUST ALSO BE PROVIDED AS NEEDED ABOVE.

ANY ADAPTER, INTERCONNECTION DEVICES, OR SIGNAL CONDITIONERS REQUIRED TO PERFORM MAINTENANCE FUNCTIONS UTILIZING THE SUPPORT EQUIPMENT OR USED TO PERFORM ANY CALIBRATION/ MAINTENANCE ON THE SUPPORT EQUIPMENT SHALL BE IDENTIFIED. ANY SENSORS OR TRANSDUCERS PERMANENTLY INSTALLED IN THE EQUIPMENT AND COMPONENTS BEING SUPPORTED SHALL BE IDENTIFIED.

- WHETHER THE SPECIAL PURPOSE SUPPORT EQUIPMENT IS PORTABLE OR PERMANENTLY INSTALLED.
- DESCRIPTION OF ELECTROMAGNETIC INTERFERENCE/RADIO FREQUENCY INTERFERENCE RESTRICTIONS.
- TEMPERATURE RANGES FOR OPERATION AND STOWAGE.
- ANY ADDITIONAL ENVIRONMENTAL RESTRICTIONS.

NOTE

SUPPORT EQUIPMENT, TEST EQUIPMENT AND TOOLS NOT FROM THE

- HAZARDOUS MATERIAL TRANSPORTATION AND HANDLING REQUIREMENTS, SPECIALIZED PACKAGING AND HAZARD COMMUNICATION REQUIREMENTS.
- PRESENTLY ACCEPTED DISPOSAL METHODS AND REQUIREMENTS.
