

DESCRIPTION: ILSDATA (NEW COMPONENT) COTS

THIS STANDARD CLAUSE SPECIFIES THE INTEGRATED LOGISTIC SUPPORT PRODUCTS AND SERVICES REQUIRED OF THE SELLER FOR COMMERCIAL-OFF THE-SHELF (COTS) COMPONENTS. THESE ARE DESCRIBED IN THE FOLLOWING PARAGRAPHS:

THE SELLER IS REQUESTED TO PROVIDE ALL CURRENTLY AVAILABLE TECHNICAL DATA FOR THE ITEM REQUESTED BY THIS PURCHASE ORDER. THIS TECHNICAL DATA SHALL BE USED BY THE BUYER TO DEVELOP LIFE CYCLE LOGISTIC SUPPORT PRODUCTS FOR THE ITEM ORDERED. THOSE PRODUCTS INCLUDE, BUT ARE NOT LIMITED TO: REPAIR PART INFORMATION, PROVISIONING TECHNICAL DATA, TRAINING NEEDS, PLANNED MAINTENANCE REQUIREMENTS AND PROCEDURES, TROUBLE SHOOTING INFORMATION AND COMPONENT SUPPORT EQUIPMENT. THE SELLER IS NOT TO DEVELOP NEW DATA UNLESS SPECIFICALLY AUTHORIZED BY ANOTHER PORTION OF THIS ORDER.

THE BUYER AND U.S. NAVY MAY USE AND REPLICATE ANY INFORMATION, TECHNICAL DATA, COMPUTER SOFTWARE, AND/OR COMPUTER SOFTWARE DOCUMENTATION PROVIDED UNLESS SPECIFIC PROPRIETARY RIGHTS ARE ASSERTED AND IDENTIFIED BY THE SELLER.

ALL TECHNICAL DATA PERTAINING TO "NONCOMMERCIAL ITEMS" THAT IS PROVIDED SHALL COMPLY WITH AND BE PROPERLY MARKED IN ACCORDANCE WITH DFARS 252.227-7013, RIGHTS IN TECHNICAL DATA NONCOMMERCIAL ITEMS.

ALL TECHNICAL DATA PERTAINING TO "COMMERCIAL ITEMS" THAT IS PROVIDED SHALL COMPLY WITH AND BE PROPERLY MARKED IN ACCORDANCE WITH DFARS 252.227-7015, TECHNICAL DATA COMMERCIAL ITEMS.

ALL NONCOMMERCIAL COMPUTER SOFTWARE AND NONCOMMERCIAL COMPUTER SOFTWARE DOCUMENTATION THAT IS PROVIDED WITH OTHER THAN UNLIMITED RIGHTS SHALL COMPLY WITH AND BE MARKED IN ACCORDANCE WITH DFARS 252.227-7014, RIGHTS IN NONCOMMERCIAL COMPUTER SOFTWARE AND NONCOMMERCIAL COMPUTER SOFTWARE DOCUMENTATION.

ALL SUCH INFORMATION, TECHNICAL DATA, COMPUTER SOFTWARE, AND COMPUTER SOFTWARE DOCUMENTATION PROVIDED SHALL BE ACCOMPANIED BY A PROPERLY COMPLETED EB FORM NO. 84-02-5667, "NOTICE OF LIMITATION ON GOVERNMENT'S AND OTHER'S RIGHTS".

THE PARTIES AGREE TO ENTER INTO A WRITTEN NON-DISCLOSURE AGREEMENT (NDA) / PROPRIETARY DATA AGREEMENT (PDA) WHEN REQUIRED BY THE AFOREMENTIONED DFARS CLAUSES.

THE VARIETY OF TECHNICAL DATA THAT IS REQUIRED BY THE BUYER (IF AVAILABLE) INCLUDES, BUT IS NOT LIMITED TO:

- TECHNICAL DRAWINGS AND/OR SKETCHES.
- OWNER'S MANUALS, OPERATORS MANUALS, MAINTENANCE MANUALS, SERVICE MANUALS, INSTALLATION MANUAL AND PARTS LIST (S)
- ALLOWANCE PARTS LIST (APL) AND/OR NATIONAL STOCK NUMBER INFORMATION
- IDENTIFICATION OF CONSTITUENT MATERIAL
- MATERIAL NAME AND ASSOCIATED MATERIAL SPECIFICATION APPLICABLE TO LOWEST PART FOR WHICH INFORMATION IS READILY AVAILABLE.
- ANY OTHER TECHNICAL DATA AVAILABLE
- PROVIDE THIS DATA IF AVAILABLE (DO NOT DEVELOP):
- MTBF (MEAN TIME BETWEEN FAILURE) INCLUDE THE SOURCE, I.E., PREDICTION OR ACTUAL USAGE
- MTTR (MEAN-TIME-TO REPAIR). INCLUDE THE SOURCE, I.E., PREDICTION OR ACTUAL USAGE
- TRAINING MATERIALS AND/OR TRAINING AVAILABLE

THE BUYER AND U.S.NAVY MAY USE (INCLUDING SCANNING, RETRIEVING, OR REPLICATING) ANY DATA PROVIDED UNLESS SPECIFIC PROPRIETARY DATA RIGHTS ARE IDENTIFIED BY THE SELLER.

ANY TECHNICAL DATA AVAILABLE THAT IS PROPRIETARY, IF PROVIDED, SHALL BE USED ONLY IN SUPPORT OF LOGISTIC SUPPORT PRODUCT DEVELOPMENT.

SUBMITTAL SHALL BE BY LETTER AND ELECTRIC BOAT CORPORATION FORM 84-01-2974 VENDOR PROCEDURE APPROVAL REQUEST (VPAR). THE LETTER AND THE BUYER'S FORM SHALL CLEARLY IDENTIFY THE PURCHASE ORDER NUMBER, PURCHASE ORDER ITEM NUMBER AND THE BUYER'S PART NUMBER (AS IF PROVIDED ON PURCHASE ORDER) FOR WHICH THE DATA IS SUBMITTED.
