

DESCRIPTION: MODIFIED DRAWINGS

THE SELLER SHALL PROVIDE CERTIFICATION DATA SHEETS AND REVISED EQUIPMENT DRAWINGS. WHEN PROVIDED, THESE DRAWINGS MUST CLEARLY IDENTIFY ALL CHANGES MADE TO THE PREVIOUSLY ACCEPTED/QUALIFIED COMPONENT AND MUST ALSO MAINTAIN CONFIGURATION APPLICABILITY TO THE PREVIOUSLY PROVIDED COMPONENT.

THE DRAWINGS DO NOT NEED TO BE IN THE SAME FORMAT AS THE PREVIOUSLY QUALIFIED COMPONENT DRAWING, ALTHOUGH THAT FORMAT UPDATED AS NECESSARY, IS ACCEPTABLE. IF THE PREVIOUS DRAWINGS HAVE BEEN TRANSFERRED TO A DIFFERENT FORMAT, THE NEW FORMAT, UPDATED TO REFLECT THE NEW DESIGN, IS ALSO ACCEPTABLE.

EACH SET OF DRAWINGS SHALL INCLUDE A DRAWING CONTAINING A LIST OF ALL DRAWINGS USED TO MANUFACTURE OR PROCURE ANY OR ALL OF THE END ITEMS OF THE EQUIPMENT. THIS DRAWING SHALL BE TITLED "PART DRAWING REVISION LEVEL LIST FOR _____" FOLLOWED BY THE ASSEMBLY DRAWING NUMBER FOR THE EQUIPMENT. THIS DRAWING SHALL INCLUDE, IN TABULAR FORM, THE DRAWING NUMBER, REVISION UTILIZED AND TITLE OF EACH SUB-ASSEMBLY OR DETAIL DRAWING IN THE SET.

THE BUYER AND U.S. NAVY MAY USE AND REPLICATE ANY INFORMATION, TECHNICAL DATA, COMPUTER SOFTWARE, AND/OR COMPUTER SOFTWARE DOCUMENTATION PROVIDED UNLESS SPECIFIC PROPRIETARY RIGHTS ARE ASSERTED AND IDENTIFIED BY THE SELLER.

ALL TECHNICAL DATA PERTAINING TO "NONCOMMERCIAL ITEMS" THAT IS PROVIDED SHALL COMPLY WITH AND BE PROPERLY MARKED IN ACCORDANCE WITH DFARS 252.227-7013, RIGHTS IN TECHNICAL DATA NONCOMMERCIAL ITEMS.

ALL TECHNICAL DATA PERTAINING TO "COMMERCIAL ITEMS" THAT IS PROVIDED SHALL COMPLY WITH AND BE PROPERLY MARKED IN ACCORDANCE WITH DFARS 252.227-7015, TECHNICAL DATA COMMERCIAL ITEMS.

ALL NONCOMMERCIAL COMPUTER SOFTWARE AND NONCOMMERCIAL COMPUTER SOFTWARE DOCUMENTATION THAT IS PROVIDED SHALL COMPLY WITH AND BE MARKED IN ACCORDANCE WITH DFARS 252.227-7014, RIGHTS IN NONCOMMERCIAL COMPUTER SOFTWARE AND NONCOMMERCIAL COMPUTER SOFTWARE DOCUMENTATION.

ALL SUCH INFORMATION, TECHNICAL DATA, COMPUTER SOFTWARE, AND COMPUTER SOFTWARE DOCUMENTATION PROVIDED WITH OTHER THAN UNLIMITED RIGHTS SHALL BE ACCOMPANIED BY A PROPERLY COMPLETED EB FORM NO. 84-02-5667, "NOTICE OF LIMITATION ON GOVERNMENT'S AND OTHER'S RIGHTS."

SUBMITTAL SHALL BE BY LETTER AND ELECTRIC BOAT CORPORATION FORM NO. 84-01-3518 (VENDOR DRAWING AND ENGINEERING REVIEW) OR NEWPORT NEWS EQUIVALENT. THE LETTER AND FORM SHALL IDENTIFY THE PURCHASE ORDER NUMBER, DRAWING NUMBER AND THE PURCHASER PART NUMBER FOR WHICH THE DRAWING IS SUBMITTED.
