

COMMERCIAL TECHNICAL MANUALS, IN ACCORDANCE WITH MIL-M-7298C, DATED 1 NOVEMBER 1970, WITH SPECIAL EMPHASIS ON PARAGRAPHS 3.1.2.5 THROUGH 3.1.2.5.5 INCLUSIVE. THE SELLER SHALL CERTIFY ON A CONTENT ASSURANCE PAGE SUPPLIED BY THE BUYER THAT THE MANUAL APPLIES TO THE EQUIPMENT FURNISHED.

NOTE TO SELLER: TECHNICAL MANUALS REQUIRED UNDER THIS PROCUREMENT MAY BE A MANUFACTURER'S EXISTING COMMERCIAL MANUAL, OR BE SIMILAR TO, OR IDENTICAL TO A COMMERCIAL MANUAL PREVIOUSLY ACCEPTED FOR NAVAL SHIPBOARD USE PROVIDED IT MEETS THE REQUIREMENTS OF MIL-M-7298C. THE MANUAL EVALUATION SHEET AT THE END OF MIL-M-7298C SHALL BE COMPLETED AND SUBMITTED BY THE SELLER TO ESTABLISH WHETHER A COMMERCIAL MANUAL, EXISTING OR PREVIOUSLY ACCEPTED, IS ACCEPTABLE UNDER THIS PROCUREMENT, OR CAN BE MADE ACCEPTABLE BY THE ADDITION OF SUPPLEMENTAL DATA. THE SELLER SHALL NOT COMMENCE PREPARATION OF SUPPLEMENTAL DATA PAGES TO AN EXISTING OR PREVIOUSLY ACCEPTED COMMERCIAL MANUAL UNTIL WRITTEN AUTHORIZATION TO PROCEED IS RECEIVED FROM THE BUYER.

IF THE SELLER HAS AN EXISTING OR PREVIOUSLY ACCEPTED COMMERCIAL MANUAL THAT IS DETERMINED BY THE SELLER AND THE BUYER TO BE ACCEPTABLE (WITH OR WITHOUT SUPPLEMENTAL DATA) UNDER THIS PROCUREMENT, THE SET SHALL CONSIST OF:

- (A) FIVE (5) COPIES OF THE MANUFACTURER'S EXISTING OR PREVIOUSLY ACCEPTED COMMERCIAL MANUAL, ALONG WITH COPIES OF THE EVALUATION SHEET, COMPLETED BY THE SELLER, AND A DESCRIPTION OF ANY SUPPLEMENTAL DATA THAT HE INTENDS TO PROVIDE TO SATISFY THE REQUIREMENTS OF MIL-M-7298C, ATTACHED THERETO TO EACH COPY.
  
- (B) TWENTY (20) COPIES OF THE MANUFACTURER'S EXISTING OR PREVIOUSLY ACCEPTED COMMERCIAL MANUAL AND PRELIMINARY (REVIEW) SUPPLEMENTAL DATA, PREPARED IN ACCORDANCE WITH MIL-M-7298C, PARAGRAPHS 3.2 THROUGH 3.4, EIGHT (8) WEEKS AFTER WRITTEN RECEIPT OF AUTHORIZATION TO PROCEED.

- (C) 100 COPIES OF THE MANUFACTURER'S EXISTING (NEW) COMMERCIAL MANUAL IDENTIFIED AS REQUIRED BY MIL-M-7298C, PARAGRAPH 3.2.3.
- (D) ONE (1) SET OF FINAL CAMERA-READY COPY OF SUPPLEMENTAL DATA TEXT AND ARTWORK INCORPORATING ALL REVIEW AND APPROVAL COMMENTS, AS APPLICABLE, EIGHT (8) WEEKS AFTER RECEIPT OF WRITTEN APPROVAL FROM THE BUYER OF THE PRELIMINARY (REVIEW) SUPPLEMENTAL DATA.

IF THE SELLER HAS NO MANUFACTURER'S COMMERCIAL MANUAL, OR IT IS DETERMINED BY THE SELLER OR THE BUYER THAT THE MANUFACTURER'S EXISTING OR PREVIOUSLY ACCEPTED COMMERCIAL MANUAL CANNOT BE MADE ACCEPTABLE BY SUPPLEMENTAL DATA SUFFICIENT TO MEET THE CRITERIA DESCRIBED IN MIL-M-7298C, PARAGRAPHS 3.1, 3.2.2.1.8, 3.4, AND 6.4.1, HE MUST PREPARE A NEW COMMERCIAL MANUAL. THE SET SHALL CONSIST OF:

- (E) TWENTY (20) PRELIMINARY (REVIEW) COPIES PREPARED IN ACCORDANCE WITH MIL-M-7298C, PARAGRAPHS 3.2 THROUGH 3.4, SIXTEEN (16) WEEKS AFTER RECEIPT OF PURCHASE ORDER.
- (F) ONE (1) SET OF FINAL CAMERA-READY COPY OF TEXT AND ARTWORK INCORPORATING ALL REVIEW AND APPROVAL COMMENTS, AS APPLICABLE, EIGHT (8) WEEKS AFTER RECEIPT OF WRITTEN APPROVAL FROM THE BUYER OF THE PRELIMINARY (REVIEW) MANUAL.

ADDITIONAL NOTES TO SELLER:

- 1) THE BUYER WILL FURNISH EITHER A REVISED FIGURE 1 OR FIGURE 2 TO MIL-M-7298C AS APPROPRIATE, TO BE COMPLETED BY THE SELLER, A CAMERA-READY CONTENT ASSURANCE PAGE FOR SELLER CERTIFICATION, AND A REVISED CAMERA-READY USER ACTIVITY COMMENT SHEET FOR INCLUSION IN FINAL SUBMITTALS.

- 2) CAMERA-READY COPY, AS USED HEREIN, IS DEFINED AS REPRODUCIBLE COPY, COMPLETE IN ALL RESPECTS AND WITH ALL ARTWORK MOUNTED IN PLACE, PREPARED IN ACCORDANCE WITH MIL-M-38784 DATED 1 JANUARY 1968, (SEE MIL-M-7298C, PARAGRAPH 3.2.2.1.6), READY FOR THE INTERMEDIATE STEP OF PREPARATION OF PHOTOLITHOGRAPHIC NEGATIVES FOR PRINTING.
