A CHANGE OR UPDATE REVISION MUST CONFORM TO THE FORMAT OF THE EXISTING MANUAL AND PROVIDE COVERAGE FOR ALL EXISTING CONFIGURATIONS.

ANY CHANGE OR REVISION MUST BE REVALIDATED TO THE LEVEL OF THE EXISTING MANUAL UNLESS OTHERWISE SPECIFIED BY THE BUYER.

ALL PHASES OF PREPARATION AND HANDLING SHALL BE EXPEDITED AS DESCRIBED IN THE PURCHASE ORDER. SELLER SHALL PROVIDE DELIVERABLES IN ACCORDANCE WITH DELIVERY DATES SPECIFIED IN THE PURCHASE ORDER.

- A) ONE (1) COPY OF TECHNICAL MANUAL QUALITY ASSURANCE DATA IN ACCORDANCE WITH TMCR ALONG WITH CONTENT ASSURANCE PAGE.
- B) TEN (10) COPIES OF A NEW PRELIMINARY CHANGE/REVISION IN ACCORDANCE WITH TMCRS EB NSSN-000 AND EB NSSN-004. NOTE: MORE THAN ONE (1) ITERATION OF THE PRELIMINARY MAY BE REQUIRED BEFORE IT IS ACCEPTABLE TO SUBMIT TO THE NAVY FOR APPROVAL. ALSO SUBMIT ONE (1) COPY OF THE DIGITAL FILES USED TO PREPARE THE PRELIMINARY MANUAL.
- C) ONE (1) SET OF CAMERA-READY REPRODUCIBLES OF ITEM (C) AFTER APPROVAL OF THE PRELIMINARY AS REQUIRED BY TMCR EB NSSN-000 AND PACKAGED ACCORDINGLY.
