THE CERTIFICATION MUST BE FORWARDED WITH A COMPLETE OR PARTIAL SHIPMENT UNDER THIS ORDER. MATERIAL WILL BE REJECTED IF THE CERTIFICATION IS NOT RECEIVED.

IN THE EVENT THAT TESTING HAS BEEN COMPLETED BUT RESULTS WERE NOT TRANSMITTED TO BUYER, SELLER MUST FURNISH COPIES OF THE RESULTS TO BUYER FOR ENGINEERING REVIEW AND APPROVAL PRIOR TO DELIVERY OF THE EQUIPMENT.

ALL OTHER TESTS AND INSPECTIONS REQUIRED BY THE STANDARD DRAWING AND/OR SPECIFICATION MUST BE COMPLETED AND COPIES OF THE RESULTS FORWARDED WITH THE EQUIPMENT.
