

NFPA-701 TEST METHOD 2

FIRE RETARDANT TESTING AND CERTIFICATION IN ACCORDANCE WITH NFPA-701 TEST METHOD 2 ARE REQUIRED TO BE ACCOMPLISHED BY THE VENDOR PRIOR TO MATERIAL SHIPMENT TO EBC. THE FOLLOWING COMPANY IS AN EBC-APPROVED LAB FOR THIS TEST.

THE USE OF ANY OTHER LAB(S) SHALL BE APPROVED PRIOR TO TESTING BY EBC DEPT 341 NON-METALLIC MATERIALS ENGINEERING VIA VENDOR SUBMITTAL OF A VENDOR INFORMATION REPORT (VIR). THE VIR SHOULD INCLUDE THE NAME, ADDRESS AND PHONE NUMBER FOR THE PROPOSED LAB(S).

THE EBC-APPROVED TEST LAB WILL IDENTIFY THE SIZE AND LOCATION OF THE SAMPLE MATERIAL REQUIRED FOR TESTING.

SEPARATE LAB TEST REPORTS ARE REQUIRED FOR ALL DIFFERENT BATCH NUMBERS USED TO FULFILL THE PURCHASE ORDER QUANTITY.

FIVE COPIES OF THE SIGNED AND CERTIFIED LAB TEST REPORTS ARE REQUIRED. PRIOR TO MATERIAL SHIPMENT TO EBC THE VENDOR SHALL FORWARD ONE COPY OF THE LAB CERTIFICATION TO THE EBC BUYER AND ONE COPY TO THE EBC FIRE DEPARTMENT, ATTENTION FIRE CHIEF. ONE COPY OF THE FIRE TEST RESULTS MUST BE SUBMITTED TO EBC DEPT 343 NON-METALLIC MATERIALS ENGINEERING FOR APPROVAL PRIOR TO SHIPMENT. THE OTHER TWO LAB TEST REPORT COPIES ARE TO BE FORWARDED WITH THE MATERIAL SHIPMENT.

IN LIEU OF MARKING THE MATERIAL, SELLER MAY STATE BATCH AND DATE OF MANUFACTURE ON THE PACKING SLIP, CERTIFICATE OF CONFORMANCE, LAB TEST REPORTS, REGARDING THE MATERIAL SHIPMENT.

NOTE

FOR VENDOR SERVICE POS, IF SELLER IS BRINGING FIRE RETARDANT MATERIAL TO PERFORM THEIR WORK (WHICH HAS NOT BEEN PREVIOUSLY APPROVED BY EB), A VENDOR INFORMATION REQUEST (VIR) BY THE CONTRACTOR OR SUPPLIER IN ACCORDANCE WITH MDD-00596 WITH THE APPLICABLE LAB TEST RESULTS MUST BE SUBMITTED AND APPROVED BY D343 AND EB FIRE CHIEF.
