SHOULD SIMILAR OR IDENTICAL EQUIPMENT HAVE BEEN TESTED IN ACCORDANCE WITH THE ABOVE REQUIREMENTS, THEN DCAS INSPECTION IS NOT REQUIRED. DETAIL PROOF OF SUCH TEST WITH NAVY APPROVAL LETTER WILL BE REQUIRED TO BE SUBMITTED TO NORTHROP GRUMMAN NEWPORT NEWS FOR REVIEW OF VIBRATION EXTENSION REQUESTS WITHIN 30 DAYS AFTER RECEIPT OF THIS ORDER.

NOTE: ONLY WRITTEN CONFIRMATION ADVISING THE APPLICABLE TEST REPORT NUMBER, NAVY APPROVAL LETTER AND EQUIPMENT ASSEMBLY DRAWING NUMBER AND REVISION IS REQUIRED WHEN THE EQUIPMENT IS IDENTICAL TO THAT PREVIOUSLY FURNISHED TO NORTHROP GRUMMAN NEWPORT NEWS PROVIDED NO ADDITIONAL DESIGN CHANGES ARE INCURRED ON THIS CONTRACT. THIS INFORMATION IS TO BE SUBMITTED TO NORTHROP GRUMMAN NEWPORT NEWS WITHIN 15 DAYS AFTER RECEIPT OF THIS ORDER.

UNLESS A DCMA (FORMERLY DCMC OR DCAS) EXEMPTION CODE IS LISTED ON PAGE (1) OF THIS PURCHASE ORDER, GOVERNMENT PROCUREMENT QUALITY ASSURANCE (GPQA) ACTION IS REQUIRED PRIOR TO SHIPMENT FROM YOUR PLANT.
