THE OPEN INSPECTION LIST may BE SUBMITTED TO NEWPORT NEWS SHIPBUILDING FOR APPROVAL VIA VENDOR INFORMATION REQUEST (VIR) IN ACCORDANCE WITH APPENDIX A. IF USED, ON THE VIR THE VENDOR SHALL INDICATE THAT THE SUBMITTAL IS INTENDED TO SATISFY THE REQUIREMENT OF THIS NOTE.

A PURCHASE ORDER MODIFICATION MAY RESULT FROM THE OPEN INSPECTION LIST EVALUATION TO SUPPORT CERTIFICATION OF REPLACEMENT/ REPAIRED LEVEL I PARTS, FABRICATION AND INSPECTION PROCESSES AND/OR PROVIDE ADDITIONAL INSTRUCTIONS, ETC.

ANY DEPARTURES FROM THE REQUIREMENTS OF THIS PURCHASE ORDER AND THE APPROVED DOCUMENTS ARE TO BE ADDRESSED ON A VENDOR INFORMATION REQUEST FORM AS SPECIFIED HEREIN. FAILURE TO COMPLY WITH THIS REQUIREMENT WILL BE CAUSE FOR REJECTION.
